Elimination - 3 <sup>rd</sup> disobedience	Elimination - 3 <sup>rd</sup> disobedience at same obstacle
8 faults - 1 <sup>st</sup> Fall of Rider	65 penalties – 1 <sup>st</sup> Fall of Rider
2 <sup>nd</sup> Fall of Rider - Elimination	2 <sup>nd</sup> Fall of Rider - Elimination
Fall of Horse - Elimination	Fall of Horse – Elimination

### **Arena Eventer Challenge (Grass Roped Arena) - Class 1 & 2**

#### **Class 1**

60cm Open Eventer Challenge.

Entry Fee £28 including £3 Medical Cover

#### **Class 2**

70cm Open Eventer Challenge.

Entry Fee £28 including £3 Medical Cover

### **Clear Round Jumping – Grass Eventer Challenge Arena (SJ's & XC Fences)**

(Following the completion of Classes 1 & 2)

£5 per round – Show Jumps can be put up to requested heights

#### **Class 1 & 2 Arena Eventer Challenge Rules:-**

Each Competitor will be required to jump a maximum of eight show jumps followed immediately by a maximum of 14 Cross Country Fences finishing over a show jump. There is an optimum time for completion. Rules & Penalties as stated in the Pony Club Show Jumping & Horse Trials Rule Books.

### **Class 3, 4 & 5**

**Show Jumping Phase in a Grass Arena.**

**Cross Country phase on the main Cross Country Course.**

#### **Class 3**

80-85cm Open Eventer Challenge.

Entry Fee £33 including £3 Medical Cover

#### **Class 4**

90cm Open Eventer Challenge.

Entry Fee £33 including £3 Medical Cover

#### **Class 5**

1-1.05m Open Eventer Challenge.

Entry Fee £33 including £3 Medical Cover

#### **Class 3, 4 & 5 Eventer Challenge Rules:-**

Each Competitor will be required to jump a maximum of nine show jumps followed immediately by a maximum of 16 Cross Country Fences located on the main Cross Country Course finishing over a show jump. There is an optimum time for completion. Rules & Penalties as stated in the Pony Club Show Jumping & Horse Trials Rule Books.

1. The Judges decision is final. Objections must be made in writing within 10 minutes of the results being published with a deposit of £20, (refundable if objection is upheld).
2. Save for the death or personal injury caused by the negligence of the organisers, or anyone for whom they are in law responsible, neither the organisers of this event or The Pony Club nor any agent, employee or representative of these bodies, nor the landlord or his tenant, accepts any liability for any accident, loss, damage, injury or illness to horses, owners, riders, spectators, land, cars, their contents and accessories, or any other personal property whatsoever, whether caused by their negligence, breach of contract or in any other way whatsoever. Entries are only accepted on this basis.
3. The organisers of this event have taken all reasonable precautions to ensure the health and safety of everyone present at this event. For these measures to be effective, everyone must take all reasonable precautions to avoid and prevent accidents. They must obey the instructions of the organisers and all officials and stewards.
4. All non Pony Club competitors are not covered by The Pony Club Insurance and must have their own third party cover. The NCHPC Branch of The Pony Club and the organisers of this event are not legally responsible for non Members and their insurance will not cover you.
5. The Organisers reserve the right to refuse an entry, restrict entries and make alterations when necessary.
6. Hard hats to CURRENT APPROVED SAFETY STANDARDS with chinstrap must be worn for all classes or while mounted. No fixed peaks.
7. All Competitors must wear body / back protectors to approved British Safety Standards. Medical Armbands must be worn. Pony Club Members – Spurs may be worn with written permission from the riders District Commissioner.
8. Horse / ponies under the age of 4 years or stallions are not permitted at the event.
9. No refunds will be given except on receipt of valid Veterinary or Doctors Certificate.
